
In producing herewith the arrested accd. persons namely 1. Binod Hansda (25 yrs.) S/O- Lt. Motilal Hansda 2. Babunath Murmu (20 yrs.) S/O- Thakurdas Murmu both of Vill- Rangamatia, PO- Nanduka, PS- Raghunathpur, Dist- Purulia, 3. Ranjit Besra (28yrs.) S/O- Nunaram Besra of Vill- Sugnibasa, PS- Hura, Dist- Purulia, 4. Buddhadeb Mandal (19 yrs.) S/O- Chinmoy Mandal of Vill- Hadalda, PS- Kashipur, Dist- Purulia.

Today (20.08.2020) I SI Joydev Mahato along with C/752 Durjodhan Sing Sardar and JC/1347 Sushil Mahato and NVF/827 Sukram Mahato were performing day mobile duty vide Hura PS GDE No- 706 Dated- 20.08.2020 and CC No 3282/20 dtd. 20.08.2020 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 17.05 hrs, when myself along with force reached at Nimtala morh area under Hura P.S. we found 04 (four) persons namely 1. Binod Hansda (25 yrs.) S/O- Lt. Motilal Hansda 2. Babunath Murmu (20 yrs.) S/O- Thakurdas Murmu both of Vill- Rangamatia, PO- Nanduka, PS- Raghunathpur, Dist- Purulia, 3. Ranjit Besra (28yrs.) S/O- Nunaram Besra of Vill- Sugnibasa, PS- Hura, Dist- Purulia, 4. Buddhadeb Mandal (19 yrs.) S/O- Chinmoy Mandal of Vill- Hadalda, PS- Kashipur, Dist- Purulia without having mask were moving aimlessly. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives we arrested all the above noted 04 (four) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 04 (four) persons came out from their home without having mask and moving aimlessly without any valid reason for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 and 283-CS/2020 dated 21.07.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case U/S- 188 IPC & Read with section 51(b) of National Disaster Management Act, 2005 may kindly be started against 04 (four) arrested persons namely 1. Binod Hansda (25 yrs.) S/O- Lt. Motilal Hansda 2. Babunath Murmu (20 yrs.) S/O- Thakurdas Murmu both of Vill- Rangamatia, PO- Nanduka, PS- Raghunathpur, Dist- Purulia, 3. Ranjit Besra (28yrs.) S/O- Nunaram Besra of Vill- Sugnibasa, PS- Hura, Dist- Purulia, 4. Buddhadeb Mandal (19 yrs.) S/O- Chinmoy Mandal of Vill- Hadalda, PS- Kashipur, Dist- Purulia and arrange for its investigation.
