

S/O- Debakar Bouri of Vill- Pairachali (Bouri Para), PS- Indpur, Dist- Bankura, 3. Sushil Hansda (23 yrs.) S/O- Rabilochan Hansda of Vill- Pabra pahari, PS- Kashipur, Dist- Purulia, 4. Baburam Soren (25 yrs.) S/O- Lt. Ananda Soren of of Vill- Pabra pahari (Majhi para), PS- Kashipur, Dist- Purulia.

Today (21.08.2020) 1 SI Joydev Mahato along with C/827 Nityananda Mahato and JC/1374 Sk. Belal Ansary were performing day mobile duty vide Hura PS GDE No- 764 Dated- 21.08.2020 and CC No 3288/20 dtd. 21.08.2020 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 17.05 hrs, when myself along with force reached at Lalpur morh area under Hura P.S. we found 04 (four) persons namely 1. Narayan Bouri (45 yrs.) S/O- Lt. Haripada Bouri of Vill- Jorberia, PS- Hura, Dist- Purulia 2. Gouranga Bouri (40 yrs.) S/O- Debakar Bouri of Vill- Pairachali (Bouri Para), PS- Indpur, Dist- Bankura, 3. Sushil Hansda (23 yrs.) S/O- Rabilochan Hansda of Vill- Pabra pahari, PS- Kashipur, Dist- Purulia, 4. Baburam Soren (25 yrs.) S/O- Lt. Ananda Soren of of Vill- Pabra pahari (Majhi para), PS- Kashipur, Dist- Purulia without having mask were moving aimlessly. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives we arrested all the above noted 04 (four) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 04 (four) persons came out from their home without having mask and moving aimlessly without any valid reason for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 and 283-CS/2020 dated 21.07.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case U/S- 188 IPC & Read with section 51(b) of National Disaster Management Act, 2005 may kindly be started against 04 (four) arrested persons namely 1. Narayan Bouri (45 yrs.) S/O- Lt. Haripada Bouri of Vill- Jorberia, PS- Hura, Dist- Purulia 2. Gouranga Bouri (40 yrs.) S/O- Debakar Bouri of Vill- Pairachali (Bouri Para), PS- Indpur, Dist- Bankura, 3. Sushil Hansda (23 yrs.) S/O- Rabilochan Hansda of Vill- Pabra pahari, PS- Kashipur, Dist- Purulia, 4. Baburam Soren (25 yrs.) S/O- Lt. Ananda Soren of of Vill- Pabra pahari (Majhi para), PS- Kashipur, Dist- Purulia and arrange for its investigation.
