


An application u/s 156 (3) Cr.P.C. on behalf of the petitioner above named;

MOST RESPECTFULLY SHEWETH-

- 1. That, Complainant is a house wife, and permanent resident of Village- Kuki, P.S. Jhalda, District- Purulia.
- 2. That, complainant's husband is the owner of one M.R. shop, where in the accused person used to work as a daily wages worker, and used to look after agricultural works of landed properties. This way the accused person gains faith of complainant's family. He took complainant's ailing husband to Registry office on the pretext that there is some official works relating to M.R. Shop and fraudulently got executed two Registered Deeds for some landed properties.

But the matter was not know to the complainant's family.

Once the accused person disclosed that he has purchased lands, then complainant and her family members suspected.

Then complainant caused searching on 20/05/20 at Jhalda Registry Office and came to know that accused person got executed two Registered deeds, one deed containing forged signature, other containing L.T.I. Deeds bearing No. I-137 dated 06/02/2017, and I-1627/1601 dated 12/07/2017

- 3. That, then on 02/06/2020 complainant informed the matter before Officer-in-Charge of Jhalda P.S. but nothing was done by him.
- 4. That, on 02/07/2020 the complainant went to the office of the Superintendant of Police at Purulia and again lodged written complaint there mentioning about the incident and filling of written complaint at Jhalda P.S. but this time as well police did not take any action.
- 5. That, due to the above mentioned reasons and without having any other alternative your petitioner is filling this complaint before this Ld. Court of Law. And your petitioner is not in a position to continue the case at her own cost, apart from that investigation through police is required.

Under the aforesaid circumstances the petitioner prays that your Honour may kindly be pleased to send this petition of complaint under the provision of section 156 (3) of Cr.P.C. to the Officer-in-charge of Jhalda P.S. to treat the same as F.I.R. for investigation.
