Sir,

In producing herewith the arrested accused person namely Nilkant Mahato (50) S/o Tulsi Mahato of 79, Pravat Colony, PS – Dumri, Dist.- Giridih, Jharkhand, (driver) 2) Krishna Bhuiya (22) S/O- Jagdish Bhuiya of Bedkaro basti, PS- Gandhinagar, Dist- Bokaro (Khalasi) of truck No. JH 10AV9127 and seized three trucks No. JH 10AV9127, JH02N/4439, JH02S/6909 loaded with approx 25 MT coal each total 75 MT coal as per seizure list and submit a written complaint to the effect that on 18.08.2020 myself along with C/969 Niranjan Mahato, C/1374 Sujit Mandal, JC636 Dinesh Duley all of Joypur PS were performing Day Mobile Duty on Bokaro – Purulia road vide CC No-3269/20 dated-18/08/2020 and at about 13:15 hrs. received a source information that the above noted truck loaded with coal was coming from Bokaro side towards Chas More. After receiving such information, I informed the matter to IC Joypur PS and as per his kind direction we proceeded to work out the information. When we reached near Gunja more found 03 (three) trucks having registration no as noted above were proceeding towards Ramkrishna Mahato Govt. engineering college. After chasing we able to detained 03 (three) trucks near Chas Road Railway Station. We stopped the said three trucks and after seeing police, the driver and khalasi of two trucks having no JH02N/4439, JH02S/6909 were fled away. However, we could able to apprehend the driver and khalasi of trucks No. JH 10AV9127 on search, it is found that the said three truck were loaded with approx 25 MT coal each and on asking driver of the said truck failed to produce any papers in respect of said coal as well as papers in respect of the said truck. He also made incoherent statement in respect of possession of the said coal in his truck which he was driving. So, it is reasonable to believe that the driver and owner of the said truck collected the said coal either by theft or by any fraudulent means from anywhere and transporting the same to run clandestine business for wrongful gains after making criminal conspiracy. On interrogation, the driver of the said truck confessed his guilt. As such, it is every reason to believe that the driver and owner of the said three trucks No. JH 10AV9127, JH02N/4439, JH02S/6909 transporting coal illegally. As such I arrested the accused driver and khalasi of above noted truck namely Nilkant Mahato (50) S/o Tulsi Mahato of 79, Pravat Colony, PS – Dumri, Dist.- Giridih, Jharkhand, (driver) 2) Krishna Bhuiya (22) S/O- Jagdish Bhuiya of Bedkaro basti, PS- Gandhinagar, Dist- Bokaro (Khalasi) after observing all formalities and narrating him the ground of arrest. I also seized three trucks having registration No. JH 10AV9127, JH02N/4439, JH02S/6909 loaded with approx 25 MTs each total 75 MT suspected to be stolen coal under proper seizure list duly signed by the accused driver and witnesses. No public witness was available there. Approx 01 (One) K.G. of Coal sealed & labeled as sample coal from major contraband.

I therefore pray before you, kindly lodge an FIR against the driver namely Nilkant Mahato (50) S/o Tulsi Mahato of 79, Pravat Colony, PS – Dumri, Dist.- Giridih, Jharkhand, (driver) 2) Krishna Bhuiya (22) S/O- Jagdish Bhuiya of Bedkaro basti, PS- Gandhinagar, Dist- Bokaro (Khalasi) and owner of the truck bearing No JH 10AV9127 and driver and owner of two trucks JH02N/4439, JH02S/6909 as per law and arrange for its investigation.
