

The above named complainant begs to state as follows:-

- 1. The complainant is the wife of the Accused no. 1 and their marriage was solemnized on 29.4.2012 as per Hindu rites and customs after obeying all the formalities prevailing in their community and their marriage tie is still subsisting.
- 2. That after marriage the complainant went to the matrimonial house at village Kemla and began to live their there with her husbam and other family members of her husband.
- 3. That at the time of marriage the father of the complainant gave a cash of Rupees fifty thousand, one pair of Golden ear ring, one Gold chain, utensiles and Beding to the accused persons as per his capacity.
- 4. That from the very begining of the starting of conjugal life the Accused persons were not happy with the the downies which were brought by the complainant to the materimonial home and over that issue, the accused persons used to taunt her and also throw abusive and objectionable languages aiming at the parents of the complainant.
- 5. That however the complainant was bearing all such torture on the x expectation that there would develop



good sense in the mind of the accused persons. And the complainant gave birth one male child. Then the complainant with hope that good day will come but in vain.

- 6. That after five years since marriage the Accused persons put pressure on her to bring a sum of rupees fifty thousand only from her father for starting a new business. The same was intimated by the complainant to her father am her father expressed his inability to meet the further demand.
- 7. That hearing the negative answer from the father side of the complainant the accused persons became farious and started abusing her am also deprived her with all necessities and in that processes she was also assulted by the accused no. 1 being instigated by accused no. 2, such cruelty and harrasement continued day to day some times by jointly and some time by accused no. 1 and make the life of the complainant is horriable and restless.
- 8. That on 26.4.2019 the accused persons drove out the complainant and her minor son after assulting her mercilessly from their house there after the complainant and herminor son any how came to the house of her father at village Chakirban and water stated all the facts of her relatives and since then the complainant and her son have been residing with her father.





- 9. That there after a several occassion the relatives of the complains it tried to their leavel best to maximum understand the accused persons but they did not pay any head not only that they also abused them in filthy language.
- 10. That the complainant laudged a written complain before O/C Kenda p.s. against the accused persons but police personal of Kenda p.s. not to take any step against them, then the complainant loudged a written complain t before S.P. Purulia on 03.2.2020. but off no good.
- 11. That the accused persons have committed offence u/s 498 A/34 I.P.C.
- 12. That the accused person is one poor lady, she is totally depends upon his father and could not effored the expenses of the case for which the complainant seek justice.

It is, therefore prayed before your honour would be pleased to direct the officer-in-charge Kemla p.s. for investigation of the case against the accused persons by treating this complain as F.I.R. as provided u/s 156(3) Cr.P. ode.
