Sir,

I, SI Ashoke Kr. Mahato of Kenda PS, Dist- Purulia do hereby lodge a written complaint against (i) Hiralal Paramanik (37), S/o- Lt. Kitu Paramanik of Vill- Penchara , PS- Kenda, Dist- Purulia to the effect that today on 20/08/2020, as per direction while I along with J.C/191 Kanchan Sing & HG – 1784 Rajendra Majhi all are of DPF Purulia now camp at Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. While we reached at Rajnowagarh village at about 12.25 hrs. found that the above noted person along with others moving here and there without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to detain the above noted accused person

So, there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to human life and violated Government rule.

Therefore, I pray a specific case may kindly be started against Hiralal Paramanik (37), S/o- Lt. Kitu Paramanik of Vill- Penchara , PS- Kenda, Dist- Purulia as per proper section of law.
