I, SI Ashoke Kr. Mahato of Kenda PS, Dist- Purulia in producing here with the following

S/o- Mariram Mahato both of Vill- Majhihira, PS- Manbazar, Dist- Purulia do hereby lodge a  
written complaint against them to the effect that today on 22/08/2020, as per direction while I  
along with J.C 599 Bubun Mahanti & HG - 1784 Rajendra Majhi all are of DPF Purulia now camp  
at Kenda PS engaged in special mobile duty at Kenda PS area for implementation of Government  
rules regarding Lockdown Disaster Management Plan. While we reached at Kenda Thana more at  
about 15.35 hrs. found that the above noted persons along with others moving here and there  
without wearing of mask during this pandemic situation and not maintaining the social distancing  
and seeing the police parties some of them fled away and we are able to arrest the above noted  
accused persons, as there is every possibility that the above noted accused persons moving here and  
there without wearing a mask which violates the compliance of norms of wearing of mask during  
this pandemic situation and committed negligent act likely to spread infection of disease dangerous  
to human life and violated Government rule.

Therefore, I pray that a specific case may kindly be start against i) Achinta Mahato (24yrs),  
S/o- Subhas Mahato (ii) Amrit Mahato (19yrs) S/o- Mariram Mahato both of Vill- Majhihira, PS-  
Manbazar, Dist- Purulia as per proper section of law.
