Mahato & NVE/710 Allauddin Ansary both of Kenda P.S were engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding prevention from infection of disease cause by Corona virus (COVID-19) . While we reached at Kenda Thana More at about 17:25 hrs. found that the above noted persons along with others were gossiping without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease which dangerous to human life and they also violated Government rule.

Therefore, I pray that a specific case may kindly be start against (i) Rabi Majhi (21), S/o- Tuken Majhi of Vill- Panipathar , PS- Kenda, Dist- Purulia (ii) Naren Hansda (24) S/o- Ghaptu Hansda of Vill- Ulidih , PS- Tamna, Dist- Purulia (iii) Dhananjoy Bhuinya (27) S/o- Sudhir Bhuinya of Vill- Tara, PS- Tamna , Dist- Purulia as per proper section of law.
