I SI Tapas Kr. Mishra, O/C Kenda PS do hereby lodged a suo-motu complaint against arrested accused persons namely Vim Mahato (37 Yrs.), S/o- Pandav Mahato of Vill- Sarishabahal (Tola- Kurchidih), PS- Barabazar, Dist- Purulia u/s 188/269/270 IPC and 51 (1)(b) of Disaster Management Act- 2005 to the effect that on today (i.e. 19/08/2020) during special Covid-19 mobile duty at Kenda PS for implementation of Government rules regarding Lockdown Disaster Management Plan I along with C/181 Rabban Sekh & NVF/673 Rabi Sing Sardar visited different areas under Kenda PS and at about 16.45 hrs. I found that a gathering appeared at Kesya Mohr gossiping each other without mask during this pandemic situation and seeing the police parties some of them fled away and we are able to detain the above noted accused person.

So, there is every possibility that the above noted accused person gossiping with others without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to life and violated Government rule in Covid-19 pandemic situation.

Accordingly, I arrested him for disobedience to order duly promulgated by public servant after maintaining all rules of arrest, issued memo of arrest. I informed him and his relatives regarding the ground of arrest. i.e. as per section 3 of the Epidemic Diseases Act, 1897, provide penalties for disobeying any regulation or order made under the Act. These are according to Section 188 of the Indian Penal Code (Disobedience to order duly promulgated by Public Servant). As the section is bailable in nature I offered him for bail on surety but nobody stood up as surety. After that I brought the arrested accused person at PS after medically treated at Chakaltore BPHC.

Hence, I do record Kenda PS Case No. 62/20 dtd. 19/08/20 u/s 188/269/270 IPC and 51 (1)(b) of Disaster Management Act- 2005 against Vim Mahato (37 Yrs.), S/o- Pandav Mahato of Vill- Sarishabahal (Tola- Kurchidih), PS- Barabazar, Dist- Purulia as suo-motu and directed ASI Sk. Ali Hossain to investigate the case.
