

Chandī Charan Mahato Both of Vill- Bagdega , PS- Manbazar, Dist- Purulia (iii) Rabilochan Mahato (29) S/o- Dilip Kr. Mahato of Vill- Bagdega, Tola Chirkadih PS- Manbazar, Dist- Purulia do hereby lodge a written complaint against them to the effect that today on 27/08/2020, as per direction while I along with HG- 1425 Ashoke Kr. Mahato of Kenda P.S & NVF - 1784 Rajendra Mahato of DPF Purulia now camp at Kenda PS were engaged in special mobile duty at Kenda PS area for implementation of Government rules regarding Lockdown Disaster Management Plan. While we reached at Kenda Sardardih More at about 13.25 hrs. found that the above noted persons along with others were gossiping without wearing of mask during this pandemic situation and not maintaining the social distancing and seeing the police parties some of them fled away and we are able to arrest the above noted accused persons, as there is every possibility that the above noted accused persons moving here and there without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease which dangerous to human life and they also violated Government rule.

Therefore, I pray that a specific case may kindly be start against (i) Achinta Mahato (30), S/o- Sudhir Mahato (ii) Haradhan Mahato (41) S/o- Lt. Chandī Charan Mahato Both of Vill- Bagdega , PS- Manbazar, Dist- Purulia (iii) Rabilochan Mahato (29) S/o- Dilip Kr. Mahato of Vill- Bagdega, Tola Chirkadih PS- Manbazar, Dist- Purulia as per proper section of law.
