Sir,


In producing here with 03 (Three) arrested accused namely 1) Nirmal Karmakar (27) S/O- Chandra Karmakar of vill- Pokharia, PS- Purulia (M), Dist-Purulia 2) Dipak Mahato (24), S/O- Gobardhan Mahato of village - Gopalpur tola Baruyadih, P.S- Jhalda, Dist- Purulia 3) Merkhu Mahato (44) S/O- Banamali Mahato of vill- Saramba, PS-Jhalda, Dist-Purulia.

I SI Purnendu Datta of Kotshila PS do here by lodged a complaint against above noted 03 accused persons to the effect that on 05.08.2020 at about 13:35 hrs as per direction we were engaged for spl checking duty at Kotshila hat tola more on Kotshila Jhalda main road for implementation of complete lock down that found 03 persons coming from Rakhbore side. We detained them. On being asked the following persons could not be able to give any satisfactory answer for that movement on the road or they could not be able to give reasonable ground for this movement during this lock down day. So there is every reason to believe that the said three persons came out from their home and moving aimlessly or making fun. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, and 10/04/2020 and also order no 79-CS/2020 Dated-12.04.2020 & 79-CS/2020 Dtd-12.04.2020 & memo no-272-CS /2020 Dated:- 30.06.2020, order no-382-I-S.S-2 M-24/2020 Dtd-02.07.2020 of Addl CS Home & hill affairs and special order vide memo no-283-CS/2020 Dated:-21.07.2020 are in force. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- H & F W/120/20 dated 22.03.2020 which is extended till 31.07.2020 & special order vide memo no-287-CS/2020 Dated:-03.08.2020 for 05.08.2020, 08.08.2020, 20.08.2020, 20.08.2020, 21.08.2020, 27.08.2020, 28.08.2020 from 6 am to 10 pm on each day. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life and violated Quarantine rule. So, I arrested the above noted 03 (Two) accused persons in between 12.15 hrs, 12.25 hrs & 12:35 on 05.08.2020, brought them to P.S. I offered them for medical treatment but they denied.

Hence I therefore pray that a specific case may kindly be started against above mentioned persons U/S-188/34 IPC & Section 51 in the National Disaster Management Act, 2005.
