Today (10.08.2020) while I was returning from Asansol, one Uttam Roy of Narayanpur suddenly met with me at Parbelia Bazar and he ride with me in the car bearing No-WB – 82C – 3178 (Maruti Breeza) and we came to Sarbari More at about 11:10 AM. After that he told me to take some tea and snacks, accordingly I stopped the car and come to a tea stall. Suddenly Uttam Roy take the keys of the car from me and told me wait a while I have an emergence job, I will come back after 15-20 minutes. But after 1 hour he has not come, then I called Uttam Roy (Mob No-9932217811) with my mobile, then he threatened and directed me to return back to my home by bus, I will not give the car to you. Further it is to inform you that Rs. 2,10,000/- (Two lakh ten thousand) is in the dash board of the car.

In the view of the above you are therefore requested to kindly intervene into the matter and arrange to return the said car along with the aforesaid amount to me and also take lawful action against Uttam Roy.

Hope you will take necessary steps and do the needful.


