Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd person namely Samiran Chakraborty (30 Years) S/O- Tapan Chakraborty of Vill-Benipur, PS-Neturia, District- Purulia with seizure of 26 pcs. Sealed bottles of Dil Se Country spirit containing 375 ml. each which were seized under proper seizure list.

I beg to submit that today (14.08.2020) while I, ASI Tarapada Mete along with force were performing Special Mobile duty vide Neturia PS GDE No- 648 Dt. 14.08.2020 and acting on source information after consulting you at about 18:30 hrs reached at Jhanka More and held raid in the hotel styled as "Matashree Hotel" of Samiran Chakraborty (30 Years) S/O- Tapan Chakraborty of Vill-Benipur, PS-Neturia, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his hotel, on demand Samiran Chakraborty failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S- 67 BE Act and also 26 pcs. Sealed bottles of Dil Se Country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of seizure. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Samiran Chakraborty (30 Years) S/O- Tapan Chakraborty of Vill-Benipur, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1) C/1353 Atanu Ganguly, 2) NVF/578 Niranjana Hembram and 3) NVF/530 Dilip Singh all of Neturia PS accompanied me.

Under the above facts and circumstances I therefore pray that a specific case may kindly be started against Samiran Chakraborty (30 Years) S/O- Tapan Chakraborty of Vill-Benipur, PS- Neturia, District- Purulia under proper section of law.
