
I, SI Bablu Ghosh of Neturia PS, Dist- Purulia do hereby lodge a written complaint against 1) Ananda Mudi (25yrs) S/O- L. Nirmal Mudi, 2) Prasanta Mudi (20Yrs) S/O- Satish Mudi, 3) Jiten Mudi (20Yrs) S/O- Baneswar @ Bhana Mudi all of Kashidanga, PS-Neturia, Dist-Purulia to the effect that today on 20.08.2020 while I along with ASI Sujoy Kundu, C/1140 Dayamay Mahato, C/-1224 Gajan Murmu all of Neturia PS as per direction engaged in mobile duty in Neturia PS area vide Neturia PS GDE No- 918 dated 20.08.2020 & CC No- 2348/2020 Dt. 20.08.2020 for implementation of Government rules regarding Disaster Management Plan as today on 20.08.2020 fully lockdown declared by state Govt. due to COVID-19 while we reached near at Bartoria PHC under Neturia PS on Purulia Barakar Pitch Road at about 12:15 hrs we found that the above noted persons were gathered there without any valid reason and without wearing mask which violates the compliance of norms of Government order as well as wearing of mask during this pandemic situation. I took photograph all of them and asked them about their presence there but they failed to give any satisfactory answer. So, they violated the compliance of norms of Government order as well as wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188/34 IPC & 51 (1) (b) of National Disaster Management Act, 2005. I interrogated them and during interrogation they disclosed their identity noted above. After interrogation I arrested the above noted accused persons after maintaining all formalities regarding arrest as they committed cognizable offence in presence of police U/S-188/34 IPC & 51 (1) (b) Disaster Management Act, 2005 and informed ground of arrest.

Therefore, I am requesting you to start a specific case against the above noted arrested accused persons U/S- 188/34 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.


