Sub: Complaint to start a specific case.

Sir.

In producing herewith 01 (One) arrested accused person namely Ujjwal Ball (28 Years) S/O- Ashim Ball of Vill-Hijuli, PS-Neturia, Dist-Purulia do hereby lodge a written complaint against the above noted accused person to the effect that today on 27.08.2020 as per direction I, SI Bablu Ghosh, along with ASI Sujoy Kundu, C/470 Somnath Nag and NVF/530 Dilip Sing Sardar were engaged in mobile duty in Neturia PS area, which refers to Neturia PS GDE No- 1243 and CC No- 2318/20 dated 27.08.2020 for implementation of Government rules regarding lockdown Disaster Management Plan and while we reached near Parbelia Bangla High School on Saltore -Hijuli road under PS Neturia Dist Purulia at about 11:05 hrs, we found that the above noted person was coming from Hijuli side by riding a motorcycle without wearing mask. I intercepted him near Parbelia Bangla High School and took photograph and asked for his movement in lockdown period today called by state Government vide Memo No- 287-CS/2020 Dt. 03.08.2020 due to pandemic situation COVID- 19 and also asked to produce documents in respect of motorcycle. The rider of motorcycle produced valid documents in respect of his motorcycle but he failed to give any satisfactory answer regarding his movement and none wearing of mask. So, he violated the compliance of norms of Government order during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule U/S-188 IPC & 51 (1) (b) of National Disaster Management Act, 2005. I interrogated him and during interrogation he disclosed his identity noted above. After interrogation I arrested the above noted accused person after maintaining all formalities regarding arrest as he committed cognizable offence in presence of police U/S-188 IPC & 51 (1) (b) of National Disaster Management Act, 2005 and informed ground of arrest.

Therefore, I am requesting you to start a specific case against the above noted arrested accused person U/S- 188 IPC and 51 (1) (b) of National Disaster Management Act, 2005 and arrange for its investigation.
