In producing here with 06 (Six) arrested accused persons namely (1) Ardhendu Sekhar Patra (52 yrs), S/O- Lt. Kinkar Ch. Patra (2) Kanai Lal Das(60 yrs), S/O- Lt. Baidyanath Das both of vill- Laharia, PS- Puncha, Dist- Purulia (3) Prasanta Layek (28 yrs), S/O- Lt. Barid Baran Layek (4) Bablu Dutta(36 yrs), S/O- Probod Dutta (5) Bidhan Ch. Duary (37 yrs), S/O- Sudhir Duary all of vill- Poradih, PS- Puncha, Dist- Purulia and (6) Rajesh Patra (25 yrs), S/O- Dilip Kr. Patra of vill- Bhagabandh, PS- Puncha, Dist- Purulia along with Memo of arrest & other relevant

I beg to state that today (19/08/2020) I was engaged in special mobile duty near Poradih market with forces, This refers to Puncha PS GDE No- 639 Dtd- 19/08/2020 and CC No-2288 Date-19/08/2020 Accordingly, I was performing duty near Poradih market at about 11.05 hrs and I found the above noted arrested people along with 30(thirty) others were not maintaining social distance and gathered to gather at one place. I asked them to follow norms of social distancing and their reason of their gathering. None could give any satisfactory answer regarding their gathering. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of of maintain social distances during this pandemic situation. I could only arrest six of them and rest about 30(thirty) of them fled away. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 11.05 hrs to 11.45 hrs.

Therefore, I pray that a specific case may kindly be started against namely (1) Ardhendu Sekhar Patra(52 yrs), S/O- Lt. Kinkar Ch. Patra (2) Kanai Lal Das(60 yrs), S/O- Lt. Baidyanath Das both of vill- Laharia, PS- Puncha, Dist- Purulia (3) Prasanta Layek(28 yrs), S/O- Lt. Barid Baran Layek (4) Bablu Dutta(36 yrs), S/O-Probod Dutta (5) Bidhan Ch. Duary (37 yrs), S/O-Sudhir Duary all of vill- Poradih, PS- Puncha, Dist- Purulia and (6) Rajesh Patra (25 yrs), S/O-Dilip Kr. Patra of vill- Bhagabandh, PS- Puncha, Dist- Purulia, and thirty others as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, U/S 188/34 IPC and Sec 51of National Disaster Management Act, 2005 and arrange for its investigation.
