Sub: FIR

I am producing here with 02 (Two) arrested accused persons namely (1) Ganesh Bauri(30 yrs), S/O- Nimai Bauri (2) Nanda Bauri(50 yrs), S/O- Gokul Bauri both of village Dhadki, PS-Puncha, Dist- Purulia along with Memo of arrest & other relevant papers.

This is to note that today (27/08/2020) I was doing area visit to ensure complete lockdown near Dhadki with force to find out whether the lock down has been implemented properly within PS jurisdiction area or not. This refers to Puncha PS GDE No- 915 Dtd- 27/08/2020 and CC No-2341/2020, Date-27/08/2020. Accordingly, I was performing duty near Dhadki & found the above noted people were roaming aimlessly without wearing mask. I detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence I arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of compulsory wearing of mask during this pandemic situation. I issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 11.30 hrs to 11.50 hrs.

Therefore, I started a specific case (1) Ganesh Bauri (30 yrs), S/O- Nimai Bauri (2) Nanda Bauri (50 yrs), S/O- Gokul Bauri both of village Dhadki, PS-Puncha, Dist-Purulia as they disobeyed Govt order and committed negligent act likely to spread infection of diseases dangerous to life, vide Puncha PS case No-60/2020, dtd-27/08/2020 U/S- 188/34 IPC and Sec 51 of National Disaster Management Act, 2005 and endorsed its investigation to ASI Sanjay Ghosh.
