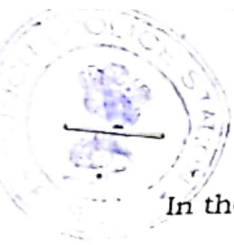

Respected Sir,

In sending here with the original FIR copy arrest memo, PR & Bail bond of accd. persons (1) Osman Ali(26 yrs), S/O- Anwar Ali (2) Rafik Ali(22 yrs), S/O- Anwar Ali (3) Durga Das Mandi(22 yrs), S/O-Nabin Mandi all of village Sialia, PO-Natherdanga, PS-Indpur, Dist- Bankura in this case and I beg to report that On 27/08/2020 SI Paromita Samaddar(O/C Puncta PS) was doing area visit to ensure complete lockdown near Budhpur more with force to find out whether the lock down was implemented properly within PS jurisdiction area or not. This refers to Puncta PS GDE No- 919 Dtd- 27/08/2020 and CC No-2341/2020, Date-27/08/2020, while she was performing duty near Budhpur more she found the above noted people were roaming aimlessly without wearing mask. She detained them and on being asked the accd people could not give any satisfactory answer regarding their movement on public place without using mask. As they refused to comply the direction given by Govt to combat covid-19 pandemic and they committed negligent act likely to spread infection of diseases dangerous to life and violated Government rules which was promulgated by Govt through public servants and through media etc for prevention of attack hence she arrested them for disobeying Govt order vide order No-382-I.S.S./2M-24/2020, Dated-2nd July 2020 of compulsory wearing of mask during this pandemic situation. She issued arrest memo and informed them the ground of arrest as per section 3 of the Epidemic Diseases Act, 1897, duly signed by the accd people. The whole process was done in between 15.15 hrs to 15.40 hrs and she started Puncta PS Case No 61/20 dated- 27/08/2020 U/S- 188/34 IPC and Sec 51 of National Disaster Management Act, 2005 against the above noted 03(Three) arrested accd people and endorsed to me for investigation.

There after one Abu Bakkar Ali, S/O- Anwar Ali of village Sialia, PO-Natherdanga, PS-Indpur, Dist- Bankura came to PS and turned up surety for arrested accd persons namely (1) Osman Ali(26 yrs), S/O- Anwar Ali (2) Rafik Ali(22 yrs), S/O- Anwar Ali (3) Durga Das Mandi(22 yrs), S/O-Nabin Mandi all of village Sialia, PO-Natherdanga, PS-Indpur, Dist- Bankura. As per order of O/C Puncta PS they were released on bail after furnishing proper bail bond and PR bond duly sign by them.
