9) That on 03/07/2020 at about 7.30 p.m. when the complainant was out of his house for working nearby village and his wife was coming back after responding nature call, she was obstructed by said Banamali paul and without giving her any oportunity to ask about such reason of obstructing her and said Banamali Paul all on a sudden poured kerosin oil on her body and set her on fire and when she raised " alarm Bancha-Pancho" some villagers namely Swapan Kumbhakar, Goutam Kumbhakar, Dhiren Kumbhakar and Meghnath Kumbhakar rushed to the place and seeing then Banamali Paul fledaway by assuring said villagers that he is going to bring a vehicle to shift her for treatment to hospital.

11) That the above named vill was informed the complainant who immediately rushed to the village and took appropriate step and shifted her to Purulia Sadar Hospital for treatment but in vain. The complainant believe that here but the accused named above has committed the crime.

12) That incident was duly informed to the Purulia (M) P. S. by the complainant and witnesses but police personal of Purulia (M), P.S. did not take any step against the miscreant, there after the complainant informed the matter to S.P. Purulia but off no good.

13) That the investigation of the matter involves number of seizer of relevent documents, P.M. report, inquest report and as well as examination the require 2 witnesses which will not possible by the complainant as his own cost and hence this complaint.
