

Most respectfully begs to state:

1. That the Complainant, Accused Persons and the Witnesses No 2 to 7, are the permanent resident of Village-Ghonga, P.S.-Purulia(M), District- Purulia having their residential houses therein.



2. That on 04/04/2020 at about 08 A.M. the father of the Complainant namely Unis Ansary, was at his home when the aforesaid Accused Persons came to the front of the house of the Complainant and started hurling abusive languages.
3. That whenupon said Unis Ansary (i.e. the Witness No.2) asked the Accused Persons not to utter such abusive languages but the Accused Persons all on a sudden entered the courtyard of the house of the Complainant with Iron Rod, Lathi, Spead etc. and assaulted said Unis Ansary mercilessly.
4. That hearing hue & cry the Complainant & the Witness No.3 & 5 came out from their room and found that the Accused Persons were assaulting said Unis Ansary with lathi, iron rod etc. on his head & other parts of his body with intent to murder him. At that time the Accused Persons also uttered that "today they will murder Unis".
5. That seeing such situations the Complainant & the Witnesses No.3 & 4 tried to rescue said Unis Ansary, when the Accused Persons also tried to assault them but they somehow escaped.
6. That hearing the hue & cry of the Complainant & the Witnesses No.3 & 4 the nearby peoples including the Witnesses No.5, 6 & 7 came there and on seeing them the Accused Persons fled away with a threatening that they will come again.
7. That said Unis Ansary due to such assault sustained bleeding injuries on his head & other parts of his person. Thereafter the Complainant with the help of the villagers took said Unis Ansary to Purulia (M) P.S. on that very date and informed the matter to the I/C Purulia(M) P.S. but the Police sent them to the D.M. Sadar Hospital, Purulia, for treatment of the injuries.
8. That the Witness No.2 was treated at D.M. Sadar Hospital, Purulia by the Witness No.8 and referred him to higher centre for better treatment for the injury so sustained by him on his persons.
9. That thereafter the Complainant brought said Unis Ansary to RIIMS, Ranchi (within Jharkhand Province) for better treatment where the Witness No.9 after treatment due to threat of Covid-19, discharged him early and advised him to stay at home and to also take medicine.
10. That the Complainant thereafter on several occasions met the I/C Purulia(M) P.S. informing about the matter in writing but the I/C Purulia(M) P.S. did not take any action in the matter up-till now.
11. That the Complainant also informed the matter to the S.P. Purulia on 02/07/2020 but up-till now no action has been taken by the police.
12. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section 156(3) of the Cr.P.C. & send the petition to the I/C Purulia(M) P.S. for investigation & further be pleased to pass necessary order.
