In producing herewith the driver namely Dipak Mahato s/o Gurucharan Mahato of Vill-Pathardih, PS- Purulia (M), Dist- Purulia along with seized Tractor (Powertrack-439 Plus) having bearing Reg. No WB55B-0277and attached with Seizure list, Memo of Arrest and Inspection Memo in respect of the supra person before you.

The nub of the fact in a nutshell is that on 25.08.2020 while I ASI Nikhil Pratap Singh along with force 1) JC/866 Bibekananda Mahato, 2) NVF/263 Kaliram Mandi of Purulia (M) PS left the PS too performing special mobile duty vide Purulia (M) PS CC No 2296/2020 and GDE No 1052 Dt. 25.08.2020 in PS area. During my special mobile duty, I received a tip off at 16:10 hrs that 01 (one) suspicious tractor loaded with sand was coming from Lukuidih village towards Gangara village. Subsequently, I along with force proceeded towards Gengara village to work out the tip off. While I along with force arrived Gengara village and found that 01 (one) tractor was proceeding towards Gengara along village road. I along with force intercepted 01 vehicle (Tractor) having Reg. No WB55B-0277 attached with Trolley is loaded with sand in between 16:35 to 16:50 hrs and I found that the vehicle as well as goods as identical as I received prior information. On being asked, the driver of the vehicle disclosed his name. I asked the driver of the vehicle to produce the valid documents in respect of the vehicle as well as the loaded sand. But the driver of the said vehicle could not able to produce any kind of documents in respect of Tractor and the sand. I repeatedly asked the driver to produce the valid paper but he stated differently in different times. The incoherent statement of the driver purported to be a suspicious to us. It was ascertained that the drivers of the tractor loaded the said sand in cahoots with the owner of vehicle by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business. So it is reasoned to belief that the accd. in cahoots with the owner of vehicle procured the said sand form Kansai River near Lukuidi village side by fraudulently means or theft by any means for transporting the same to run clandestine business. So I, seized the vehicle (Tractor) having Reg. No WB55B-0277attached with Trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them and also arrested the driver namely Dipak Mahato (23 yrs) s/o Gurucharan Mahato of Vill- Pathardih, PS- Purulia (M), Dist- Purulia after informing the ground of his arrest and issued Memo of Arrest against him. Thereafter, I brought the seized tractor to Purulia (M) PS compound.

Under the above facts and circumstances kindly take lawful action against the driver namely Dipak Mahato (23 yrs) s/o Gurucharan Mahato of Vill-Pathardih. PS-Purulia (M), Dist-Purulia and the owner of the vehicle as they committed offence u/s 379/411/414/120B of the IPC & 21(I) (4) of Mines and Minerals (R&D) Act-1957
