Sir,

In producing herewith the arrested accd. persons namely i) Sk Nasim (24) S/o Lt. Sk Ayub of Jambad, PS – Purulia (M), Dist – Purulia and ii) Sk Abdul Majid @ Abu Saba (28) S/o – Lt. Sk Suklal of Hutmura, PS – Purulia (M), Dist – Purulia along with copy of seizure list containing (a) one bhojali whose length Approx 13 inch. (Length of Iron part-9 inch Approx & length of wooden handle 4 inch approx) (b) One Taloyar (sword) whose total length is approx 33 inch (Length of iron part 28 inch approx and length of wooden handle 05 inch approx) (c) One iron rod whose length Approx 3.5 ft., (d) 04 (four) half-filled C.S. bottle, (e) One torch light, (f) some cigarettes / Bidis ends, (g) One lylon rope measuring about 20 ft. in length and (h) Auto Rikshaw (PIAGG10) Ape, bearing Reg. No. JH05AN – 9831 before your good office. I would like to draw your kind attention to the fact that, today i.e. on 25.08.2020 at about 20:35 hrs in course of my mobile duty at Barakar Road, received an information from secret source that some miscreants assembled at Chharrah Rath Tola Maidan behind Chharra Gram Panchayet Office near Chharra Hotel More with a view to committing dacoity in nearby petrol pump. Accordingly informed the matter to I/C Purulia (M) PS and noted the fact in GDE vide GDE No 1080 Dtd. 25.08.2020. As per direction of I/C myself with force C/273 Ganesh Ch. Pal, C/253 Arabinda Mallik & C1413 Kanailal Mondal Vide CC No. 2302/20 and vehicle No. WB56C-8742 being accompanied by ASI SK Hibul Hasan, C/1272 Bikash Ch. Patra, C/856 Chapulal Murmu, NVF/969 Praloy Mahato arrived approx 02 km away from their place of meeting at about 21:25 hrs. Then we kept our vehicle in that lonely place and briefed our men properly. Then we proceed slowly for their place of meeting. When we reached approx 50 mtr. away found with the help of search light that 06-08 persons sitting there in a rounded manner and talking about themselves. We moved towards them surreptitiously and tried to overhear their whispering. After a while it became clear from their conversation that they were taking preparation to commit dacoity in nearby petrol pump by overpowering their security by today night with the help of Bhujali, Rod, Taloyar (sword) etc. After satisfying their motive, suddenly we reached near them and cordoned them immediately. After identifying ourselves as Police, all the miscreants suddenly tried to flee away after having heard as we are police. We somehow managed to apprehend two (02) among them and rest miscreants managed to flee away. We asked their name and address and after a short interrogation they disclosed their name and address as noted above and confessed that they along with one Sk Jiyarul of Hutmura and Sk Biton of do and others were assembled there and preparing themselves to commit dacoity at Chharra Filling Station on Purulia-Barakar Road with a view to rob away the cash of that station. During interrogation they disclosed that they had also parked one Auto Rikshaw by the road side of Purulia-Barakar Road near Madhubon Bar about 100 Mtr. away from the place of assembling for the purpose of escaping after

commission of crime. I searched their persons thoroughly and individually and the place of assembled and recovered (a) one bhojali whose length Approx 13 inch. (Length of Iron part – 9 inch Approx & length of wooden handle 4 inch approx) (b) One Taloyar whose total length is approx 33 inch (Length of iron part 28 inch approx and length of wooden handle 05 inch approx) (c) One iron rod whose length Approx 3.5 ft., (d) 04 (four) half-filled C.S. bottle, (e) One torch light and (f) some cigarettes / Bidis ends., (g) One nylon rope measuring about 20 ft. in length

Sl No. (a) & (b) were recovered from their exclusive possession

Sl No. (c),(d),(e),(f) & (g) were recovered from the place of assembling.

Accordingly, I seized the above noted articles preparing proper seizure list duly signed by the accused persons as well as police witnesses as there was none public witness available during such odd hours of night. Thereafter I along with force reached near Madhubon Bar on Purulia-Barakar Road with two accused persons namely Sk Nasim (24) S/o-Lt. Sk Ayub of Jambad, PS – Purulia (M), Dist – Purulia and Sk Abdul Majid @ Abu Saba (28) S/o – Lt. Sk Suklal of Hutmura, PS – Purulia (M), Dist – Purulia and seized one Auto Rikshaw (PIAGGIO) Ape, bearing Reg. No. JH05AN – 9831 as shown by the aced. person. Under proper seizer list duly signed by the police witnesses as there was no public witnesses during that dark and solitary place and also signed by the accused Persons. I asked the detained persons to produce any valid documents in respect of those offending articles as well as the vehicle also and the reason of their presence in that place during odd time. But they failed to produce any valid documents and also failed to satisfy about their presence at that place during that time. As such it was beyond of doubt that the persons were assembled there to commit any cognizable crime. On further interrogation all the accused persons pleaded their guilt and stated that they along with SK Biton of Hutmura and SK Jiarul of Do and others were assembled there and preparing themselves for committing dacoity in Chharrah Filling station on Purulia-Barakar Road. Accordingly I arrested them after maintaining all legal formalities of arrest as they had committed offence punishable U/S 399/402 IPC & 25/35 Arms Act-1959 and found no external injuries on their persons and on interrogation they confessed that they are fit and fine. Prepared Memo of arrest on spot. Informed their family members over phone. Then brought them into PS with seized Alamat and kept accused in PS lock-up and handed over seized articles to I/C Purulia (M) P.S. with all documents.

Under the above fact and circumstances I pray before you that a specific case u/s 399/402 IPC & 25/35 Arms Act-1959 may kindly be started against above noted accused persons and arrange for its investigation.
