Sir,

With due respect I SI Sk. Afiruddin, beg to submit before you that on 21.08.2020 at about 20:05 Hrs while was on evening mobile Duty with force vide C.C. No- 1989/20 dated- 21.08.2020 at Telkal Para morh and found following arrested persons were wandering there without Mask and detained them subsequently at the spot. On being asked the following persons could not able to give any satisfactory answer for that wandering on the road without mask. As such the following persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated- 30.06.2020 notified extension of containment zone based lockdown upto 31.08.2020. Moreover all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society.
