With due respect I beg to submit before you that on 21/08/2020 at about 08:45 hrs. while I, SI Debabrata Chakraborty along with force were engaged on area round duty in Raghunathpur Town area and found the following persons were moving at Raghunathpur New Bus Stand on Raghunathpur – Barakar pitch road and moving aimlessly in lockdown period without wearing Mask , as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that not wearing Mask and moving aimlessly in lockdown period in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.
