Sub: Request for lodging FIR against arrested accused persons.

Sir,

With due respect I beg to submit before you that on 27/08/2020 at about 16:15 hrs. while I, SI Bangshi Badan Mondal along with force were engaged on area round duty in Raghunathpur Town area and found the following persons were moving at Adra More on Purulia – Barakar pitch road and moving aimlessly in lockdown period, as such I detained them on that spot. On being asked the following persons could not able to give any satisfactory answer for that moving aimlessly in lockdown period in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude. leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

- 1) Ratan Gope (40) S/o Lt. Lambodar Gope of Vill.- Amtore, PS – Raghunathpur, Dist.- Purulia.
- 2) Bablu Gope (37) S/o Lt. Raban Gope of Do
- 3) Saru Bauri (37) S/o Bhuban Bauri of Vill.- Laratore, PS – Raghunathpur, Dist.- Purulia
- 4) Debasis Karmakar (25) S/o Sumit Karmakar of Indira Abas Colony, Blockdanga, PS – Raghunathpur, Dist.- Purulia
- 5) Subal Bauri (25) S/o Kirity Bauri of Bediapara, Ward No 7, PS – Raghunathpur, Dist.- Purulia
- 6) Nanu Paramanik (45) S/o Lt. Santosh Paramanik of Dutta Bagan, Ward No 4, PS – Raghunathpur, Dist.- Purulia
- 7) Saktipada Bauri (35) S/o Lt. Subodh Bauri of Ekunja, PS – Raghunathpur, Dist.- Purulia

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
