Sir,

I, SI Biswarup Roy, S/O Shri Jitendra Nath Roy of Bahadurpur P.S-Jamuria, Dist- Paschim Bardhaman do hereby produced (1) Samir Gorai (42yrs) S/O- Netai Gorai of Krishnapur, PS- Santuri, Dist- Purulia (2) Sk. Jasiuddin (19 yrs) S/O- Sk. Sukur of Murulia, PS-Santuri, Dist. Purulia do hereby lodge a written complaint against them to the effect that today on 20.08.2020 while I along with C/1271 Tapas Pandit & NVF/426 Moral Besra of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 825 dtd. 20.08.2020 vide C.C. No. 3063/20 dtd. 20.08.2020 for implementation of Government rules regarding lockdown of Disaster Management Plan. While we were returning from Muradih side under Santuri P.S jurisdiction and reached at Baranti Dam Main gate through Muradi GP office Morh – Baranti village road at 14:35 hrs. found that the above noted 02(three) persons were gossiping without maintaining Lock down norms as well as without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving during lock down time without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused (1) Samir Gorai (42yrs) S/O- Netai Gorai of Krishnapur, PS- Santuri, Dist- Purulia (2) Sk. Jasiuddin (19 yrs) S/O- Sk. Sukur of Murulia, PS-Santuri, Dist, Purulia under proper section of law as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
