I, SI Gopal Chandra Man S/O Shri Dhirendranath Man of Vill. Gopinathpur, P.S Beliatore, Dist. Bankura do hereby produced (1) Biplab Nandi (28yrs) S/O- Dhiren Nandi of Poradiha near Hari Mondir PS- Santuri, Dist- Purulia (2) Sanat Bauri (32 yrs) S/O- Mantu Bauri of Kalikapur near Manasha Mondir, PS-Santuri, Dist. Purulia do hereby lodge a written complaint against them to the effect that today on 21.08.2020 while I along with C/233 Upananda Das & C/863 Rupchand Pauria of Santuri PS as per direction engaged in special mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 870 dtd. 21.08.2020 vide C.C. No. 3077/20 dtd. 21.08.2020 for implementation of Government rules regarding lockdown of Disaster Management Plan. While we were returning from Balitora side under Santuri P.S jurisdiction and reached at Poradiha Morh through Sarbari - Saltora road at 18:15 hrs. found that the above noted 02 (two) persons were gossiping without maintaining Lock down norms as well as without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving during lock down time without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused produced (1) Biplab Nandi (28yrs) S/O- Dhiren Nandi of Poradiha near Hari Mondir PS- Santuri, Dist- Purulia (2) Sanat Bauri (32 yrs) S/O- Mantu Bauri of Kalikapur near Manasha Mondir, PS-Santuri, Dist. Purulia under proper section of law as they disobeyed Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
