While we were returning from Rambhattadi side under Santuri P.S jurisdiction and reached at Santuri Morh through Raghunathpur - Saltora road (SH-8) at 17:05 hrs. found that the above noted 08 (eight) persons were gossiping without maintaining norms of COVID-19 as well as without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.
