Sir,

I, SI Gopal Chandra Man S/O Shri Dhirendranath Man of Vill. Gopinathpur, P.S Beliatore, Dist. Bankura do hereby produced (1) Buddheswar Saren (35yrs) S/O- Rasik Saren of Tilabaid, PS-Santuri, Dist- Purulia (2) Dhiren Gorai (60 yrs) S/O- Lt. Radhanath Gorai of Kalipahari, PS-Santuri, Dist. Purulia, (3) Paresh Chandra Mondal (62 yrs) S/O-Lt. Laxman Mondal of Ghoramurga, PS-Santuri, Dist-Purulia, (4) Umapada Tantubai (62 Yrs) S/O-Lt. Bhanudhar Char of Santuri, PS-Santuri, Dist-Purulia, (8) Nirmal Mandal Gope (36yrs) S/O-Binod Mandal Gope of Santuri Mandal Para, PS-Santuri, Dist-Purulia do hereby lodge a written complaint against them to the effect that today on 29.08.2020 while I along with C/1424 Bhairab Patra & NVF-131 Jahan Murmu of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 1182 dtd. 29.08.2020 vide C.C. No. 3177/20 dtd. 29.08.2020) for implementation of Government rules regarding Disaster Management Plan. While we were returning from Rambhattadi side under Santuri P.S jurisdiction and reached at Santuri Morh through Raghunathpur – Saltora road (SH-8) at 17:05 hrs. found that the above noted 08 (eight) persons were gossiping without maintaining norms of COVID-19 as well as without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask and maintaining social distancing during this pandemic situation in c/w COVID-19. So, there is every reason to believe that the above noted persons were moving without wearing a mask and maintaining social distancing which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of diseases dangerous to life and violated Government rule. So, I have arrested them maintaining all legal formalities as well as notifying the ground of arrest and informed their family members through local people.

Therefore, I pray a specific case may kindly be started against accused (1) Buddheswar Saren (35yrs) S/O- Rasik Saren of Tilabaid, PS- Santuri, Dist- Purulia (2) Dhiren Gorai (60 yrs) S/O- Lt. Radhanath Gorai of Kalipahari, PS-Santuri, Dist. Purulia, (3) Paresh Chandra Mondal (62 yrs) S/O-Lt. Laxman Mondal of Ghoramurga, PS-Santuri, Dist-Purulia, (4) Umapada Tantubai (62 Yrs) S/O-Lt. Durgadas Tantubai of Santuri, PS-Santuri, Dist-Purulia, (5) Rupam Kundu (19yrs) S/O-Samiram Kundu of Saltora, PS-Saltora, Dist-Bankura, (6) Avijit Mondal (20yrs) S/O-Rampada Mondal of Saltora, PS-Saltora, Dist-Bankura, (7) Sitaram Char (50yrs) S/O-Lt. Bhanudhar Char of Santuri, PS-Santuri, Dist-Purulia, (8) Nirmal Mandal Gope (36yrs) S/O-Binod Mandal Gope of Santuri Mandal Para, PS-Santuri, Dist-Purulia under proper section of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
