Sir,

I, SI Uttam Chatterjee, SO- Lt. Debhabbarjan Chatterjee of Patnaspura, PS- Dist- Bankura now posted at Santuri PS, Dist- Purulia do hereby produce one Rajesh Mahato (27 yrs) S/O-Nishukar Mahato of Kalipahari, PS-Santuri, Dist-Purulia and do hereby lodge a written complaint against him, to the effect that today on 19.08.2020 while I along with C/1154 Jagannath Das & NVT/717 Haren Ch. Mahato of Santuri PS as per direction engaged in mobile duty within Santuri PS area, (Reference Santuri P.S G.D.E No. 776 dt. 19.08.2020 and CC No- 3034/20 dated 19.08.2020) for implementation of Government rules while we proceeding towards Marbodia side from Hamadima under Santuri P.S jurisdiction and reached at Marbodia Moth through Raghunathpur- Sabana Road (SH-08) at about 19:55 hrs found that the above noted person was going Marbodia Moth to Kalipahari without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation in a/c COVID-19. So, there is every reason to believe that the above noted person was moving without wearing a mask which violates the compliance of norms of wearing of mask during this pandemic situation and committed negligent act likely to spread infection of disease dangerous to life and violated Government rule. I have arrested him maintaining all legal formalities as well as notifying the ground of arrest and informed his family members through local people.

Therefore, I pray a specific case may kindly be started against accused one Rajesh Mahato (27 yrs) S/O-Nishukar Mahato of Kalipahari, PS-Santuri, Dist-Purulia under proper section of law as he disobeyed Govt. order and committed negligent Act likely to spread infection of disease dangerous to life and violated Government rule and arrange for its investigation.
