No. 3128/20 dtd. 25.08.2020) for implementation of Government rules regarding Disaster Management Plan. Purulia, (3) Tapan Sarkar (37 yrs) S/O-Santi Sarkar of Kalipahari, PS-Santuri, Dist-Purulia under proper section of law as they disobeyed/ignored Govt. order and committed negligent Act likely to spread infection of diseases dangerous to life and violated Government rule and arrange for its investigation.
