Sub: Request for lodging F.I.R. against arrested accused Mangal Bauri & 01(One) others.

Sir,

In producing here with 02 (Two) arrested accused namely (1) Mangal Bauri (35) S/O Bhuban Bauri of Vill- Ramer Bagicha (2) Dasarath Bouri (61 Yrs) S/O-Lt. Sidam Bauri of Vill- Ramer Bagicha, both of PS-Adra, Dist-Purulia along with Memo of Arrest.

I SI Sourav Banerjee of Adra PS do here by lodged a complaint against above noted 02(Two) accused persons to the effect that on 07.09.2020 at about 19.45 hrs while I was on evening mobile duty at PS area vide GDE No- 253/20 dtd 07/09/20 found few persons were gathered at Chatna More under Adra P.S Dist- Purulia without maintaining social distance and without wearing musk. I aware them and directed them to send back at their respective destination as they were violating the Govt. order. But after several attempts they pay no heed to me. Finding no other way we tried to detained them. After seeing the Police party they were trying to flee away after a hot chase we managed to detained above noted 02(Two) persons and found that they were not wearing any mask and cloth covered to their mouth and nose. COVID - 19 Pandemic guidelines is going on throughout the country as well as District of Purulia in view of Pandemic of COVID-19 outbreak. They violated the order duly promulgated by government through public servants and through media etc for prevention of attack from CORONA Virus/COVID-19. They are creating annoyance to the society & violated govt. order. Though lockdown is going on throughout the District of Purulia in view of Pandemic of COVID-19 outbreak vide Govt. of India consolidated order No- 40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And orders of Govt. of West Bengal vide Order No- 177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020 and order No- 272-CS/2020 Dtd. 30.06.2020, 283-CS/2020 Dtd. 21.07.2020, 287-CS/2020 Dated 03/08/2020 and memo no. 289-CS/2020 Dtd. 12/08/2020 and order no. 298-CS/2020 Dtd. 31/08/2020 for complete restriction measure. Accordingly the above noted 02 (Two) persons were arrested in between 20.05 Hrs to 20.15 Hrs for disobedience to order duly promulgated by public servant after maintaining all rules of arrest, Issued memo of arrest & Inspection Memo. I offered them for medical checkup but they denied.

Hence I there for pray that a specific case may kindly be started against above mentioned persons U/S 188/34 IPC & Section 51 (1) (b) in the National Disaster Management Act, 2005.
