② Nayan Chakraborty, son of Dipak Chakraborty, vill+P.O. - SIRKABAD
③ Sudipta Majhi, son of Lambodar Majhi, vill+P.O. - SIRKABAD,
physically assaulted me, while I was on duty at
SIRKABAD BPHC on 02/09/2020 at around 09:05 AM.
The first two persons are not even patient, ^{they} so attacked
with a motive of murder & grievous hurt. They were
even without mask at the time of this COVID-19
pandemic and they started argument before beating
me. It was intentionally & planned attack because
they were not visited OPD (which runs from 9am to 2pm) and
but they came to indoor at around 09:05 AM.
They also broken some hospital property at indoor
of SIRKABAD BPHC.

I shall be highly obliged if you
take this letter as F.I.R. and this act should
come under "THE MEDICAL SERVICE PERSONS AND
MEDICARE SERVICE INSTITUTIONS (PROTECTION FROM
VIOLENCE AND DAMAGE TO PROPERTY) ACT, 2009
& THE EPIDEMIC DISEASE (AMENDMENT) ORDINANCE
