Respected Sir,

In producing herewith one tractor having Eng No-39.1354/HF006743A and Chesis No- WZTG35625097776 along with trolley loaded with sand along with seizure list.

I SI Sudhir Kumar Mahato of Baghmundi PS, Dist-Purulia beg to submit that on today (28.09.2020) while I along with force namely 1.C/564 Prasad Majhi, 2.C/568 Madhusudan Rajwar, both of Baghmundi PS were performing anti crime mobile duty at PS area vide Baghmundi PS C.C No-1440/2020, Dtd: 28.09.2020, I received a source information at 17:25 hrs that a suspicious tractor loaded with sand was coming from Kalimati side area. Subsequently I along with force left for the said place. While I along with force arrived at Rella More (SH-4) at 18:05 hrs, I found that one tractor was coming towards Kalimati More. I along with force intercepted the tractor attached with trolley loaded with sand and found that the vehicle as well as the loaded sand is as identical as I received the prior information. Due to the darkness and the topography, the driver of the said vehicle somehow managed to escape in a suspicious manner. Due to such suspicious activity of the driver it was ascertained that the driver of the said tractor loaded the sand with the consent of the owner of the vehicle by illegal means for selling the same to make profit by dishonestly and he had been running a clandestine business, hence it is reasoned to belief that the driver of the vehicle procured the said sand from Kalimati More side area by fraudulently means or theft by any means for transporting the same to run clandestine business along with the owner of the vehicle. Hence I seized the above noted tractor along with trolley loaded with sand under proper seizure list in presence of available witnesses duly signed by them. Thereafter I brought the seized tractor at Baghmundi PS. It is noted that the driver of the said vehicle could not be arrested.

Hence I pray before you to take legal action against the driver of the said vehicle as they have committed offences U/S-379/411/414/34 IPC & Sec. 21(1) (4) of the Mines and Minerals (R&D) Act, 1995.
