Sir,

In producing herewith 03 (Three) accused persons namely 1. Subhash Kalindi (35 Yrs), S/O- Lt. Baka Kalindi of Vill- Madla, 2. Bhaktu Mura (23 Yrs), S/O- Sarban Mura of Vill- Basudi, 3. Rakesh Gorai (20 Yrs), S/O- Futulal Gorai of Vill- Sarjumatu and all are PS- Baghmundi, Dist-Purulia to the effect that on 11.09.2020 while I SI Snehasish Mondal along with force 1) C/872 Nanigopal Das and 2) C/869 Ali Imran both of Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No- 492, Dated- 11/09/2020. During my mobile duty when myself along with force reached at Ajodhya More at 16:45 hrs and found above persons were roaming aimlessly at Ajodhya More without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & State Govt. has passed order to wear mask in the public place mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt is order no 382-1.S.S./2M-24/2020 Dtd 02.07.2020.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
