In producing herewith the accused person namely Uday Lohar (50 Yrs), S/O-Lt-Premdhan Lohar of Vill-Ukada, P.S- Baghmundi, Dist- Purulia along with seized articles 1) 19 (Nineteen) liter ID liquor containing in a white plastic Jerican, 2) One Bootle containing 500 ML of ID liquor collected from seized Jerican as sample, 3) Cash Rs. 155/- (One Hundred Fifty Five only) as sale proceed, which were seized under proper seizure list duly signed by the witness.

I beg to inform you that today on 12.09.2020 during my special mobile duty as per source information I along with 1. C/787 Suman Kanti Mondal, 2. C/869 Ali Imran, 3.C/630 Jay Sardar all are of Baghmundi P.S reached at Ukada Village at 20:35 hrs and found that the above noted person is selling I.D liquor in his dowelling house under Baghmundi P.S, Dist Purulia. On demand he failed to produce any valid document from competent authority in respect of stocking & selling of liquor. As such he has been arrested U/S- 67 B.E. Act at 20:45 hrs and also seized in his possession 1) 19 (Nineteen) liter ID liquor containing in a white plastic Jerican, 2) One Bootle containing 500 ML of ID liquor collected from seized Jerican as sample, 3) Cash Rs. 155/- (One Hundred Fifty Five only) as sale proceed which were seized under proper seizure list duly signed by the witness U/S- 67 B.E. Act. The seized article as well as the sample was labeled properly in presences of witness and accused person. I maintained all formalities regarding arrest rule as well as guide line of NHRC and also informed him and his family members regarding his arrest.

So the above noted arrested accused person namely Uday Lohar (50 Yrs), S/O-Lt-Premdhan Lohar of Vill-Ukada, P.S- Baghmundi, Dist- Purulia committed an offence U/S- 46 A(c) B.E. Act. 1909 for unauthorized possession and selling of Id Liquor from his sole possession.

Under the fact and circumstances I therefore pray before you a specific Case may kindly be started against the said accused person under proper section of law and obliged.
