Sir,

In producing herewith 02 (Two) accused persons namely 1.Sonu Sing Mura (30 Yrs), S/O-Bhola Sing Mura of Vill-Rella, 2.Setbahan Kumar (40 Yrs), S/O-Abhimunnya Kumar of Vill-Karru both of PS-Baghmundi, Dist-Purulia to the effect that on 14.09.2020 while I SI Snehasish Mondal along with force 1) C/610Achinta Bauri and 2) C/1055 Santimoy Samanta both of Baghmundi PS were performing mobile duty vide Baghmundi PS GDE No-637, Dated- 14/09/2020. During my mobile duty when myself along with force reached at Koreng More at 16:15 hrs and found above persons were roaming aimlessly at Koreng More without mask or its alternative. I detained them. On being asked the above noted persons disclosed their identity but could not able to give any satisfactory answer for that movement on road and public place.

As the pandemic period related to COVID-19 is going on and hence to prevent its mass spreading the Central Govt. & State Govt. has passed order to wear mask in the public place mandatory and ordered to prosecute the defaulters. The order of West Bengal Govt is order no 382-1.S.S./2M-24/2020 Dtd 02.07.2020.

As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal hence the detained persons is refuses to comply the direction given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic after several request.

Hence I pray before you to start a specific case against the above noted persons under proper section of law.
