Today (04.09.2020) myself SI Sanjay Diger along with force JC/380 Arijit Bera, JC/971 Sanjay Gulimajhi to were engaged in mobile duty vide CC NO- 3688/2020, GDE No-179 dt- 04.09.2020 and as per direction we were engaged for implementation of Govt. rules regarding COVID-19 Pandemic & disaster management plan. At about 15:15 Hrs, when myself along with force reached at Balarampur Bus stand under Balarampur P.S. we found 02 (two) persons namely 1) Sanjit Pal (48 yrs) S/O- Lt. Bijoy Pal, Gas Repairing Shop at Gosala Road, Balarampur, P.S- Balarampur, Dist.- Purulia, 2) Mathura Prasad Pal (57 yrs) S/O- Lt. Biswanath Pal, Pan Shop at Balarampur Gosala More, P.S- Balarampur, Dist.-Purulia without having mask were moving aimlessly and we intercepted them 1st time at Balarampur Bus stand and returned them back after giving warning regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but after half an hour later around 15:45 hrs 2nd time said 02 (two) persons again without having mask tried to pass through our Police checking point at Balarampur Bus stand and making chaos with the Police party so finding no alternatives we arrested all the above noted 02 (two) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 02 (two) persons came out from their home without having mask and moving aimlessly for making fun, in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No-272-CS/2020 dated 30.06.2020 Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case may kindly be started against 02 (two) persons namely 1) Sanjit Pal (48 yrs) S/O- Lt. Bijoy Pal, Gas Repairing Shop at Gosala Road, Balarampur, P.S- Balarampur, Dist.- Purulia, 2) Mathura Prasad Pal (57 yrs) S/O- Lt. Biswanath Pal, Pan Shop at Balarampur Gosala More, P.S- Balarampur, Dist.-Purulia.
