Subject: Damage to Plantation.

Sir,

With due respect and humble submission I beg to draw your kind attention that a person namely Birsha Munda S/O-Ganda Munda of Village-Mahalitar, P.O.-Ghatbera Kerowa, P.S.-Balarampur, Dist-Purulia has repeatedly damaged 2019-20 QGS Plantation in Plot No-60 which is Forest Land as per Calcutta Gazette Notification of Mouza-Karma, J.L.No-20 under Ghatbera Beat of Balarampur Range. Today (on 07/09/2020 at about 12-30 PM) in course of patrolling the staffs noticed that the same person (Birsha Munda) with two other persons supposed to be outsiders had entered into the plantation site with billhook in their hand and damaged some planted seedlings by themselves and by their buffalos. The staffs tried to stop them so that they cannot damage the Government Property but due to the weapons in their hand the staffs cannot resist them from damaging the Government Property.

So, we are requesting your kindness to take necessary steps so that we can protect the Government Property.
