I, the undersigned beg to draw your kind attention for the following facts for taking immediate and appropriate steps against the mischief monger.

The fact of the case is brief is that Smt. Pratima Lal Barai, the wife of Dr. Anant Lal Barai (Krishna Nand Barai) have got considerable landed properties at Mouza-Safua of Balarampur.

The description of the said property has been given below:- for your ready reference and to avoid future complicity or which may help in the act of investigation of the alleged offence which is come out by this complaint. The document it will speak the Dilip Chourasia (Bhola Sao),^{Son of Basudeb Chourasia at Balarampur (Masjid Rd)} has forged the document and/or created a Counterfeit Deed bearing no. 04262 for the year 2012 dated 18/07/2012 in connivance with Ranjit Prajapati S/o. Kalicharan Prajapati of Balarampur Mission Road along with the Deed writer Dukh Bhayan Mahato of Arjun Tara attached to sub-registry office Purulia and one female reported to be the Salika of Dilip who have personified herself as Smt. Pratima Lal Barai in respect of the landed property of Pratima. Name of the Dilip's Salika Kalyani Dhibar w/o. Subhas Dhibar. (Add:- Balarampur Purana Hospital, P.O. - Rangadik, Dist. - Purulia P.S. - Balarampur.)

The photograph affixed and/or pasted in the Deed (Non-Judicial stamp K.572359) is not the photograph of Smt. Pratima Lal Barai and the same is of another woman, who has falsely been identified as Smt. Pratima by Ranjit Prajapati knowing full well that she was not the person to whom he identifies as Smt. Pratima Lal Barai.

The bearing no. 04262 for the year 2012, dated 18/07/2012 is forged and fabricated one.

Dr. Anand Lal Barai had come at that time and we together with him had resisted Dilip, But Dilip and his ten or twelve (10-12) others, showing their criminal activity, hit us all. And with fire arm in Dr. Anand Lal's forehead, he
