Respected Sir,

In producing here with one arrested accused person namely Kishan @ Hagu Paramanik (30 yrs) S/O- Lt. Tiblu Paramanik of Vill- Rangadih, Hemalpara, P.S.- Balarampur, Dist. Purulia along with seized approx 09 (nine) liters (ID liquor) with a plastic Jarican (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs. I received a credible source information that one Kishan @ Hagu Paramanik (30 yrs) S/O- Lt. Tiblu Paramanik of Vill- Rangadih Hemalpara, P.S.- Balarampur, Dist. Purulia is selling ID liquor without any valid license from his own house at Rangadih, Hemalpara village under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Rangadih, Hemalpara village to work out the source information. Thereafter we reached at Rangadih, Hemalpara village at about 18:45 hrs as per source information, I along with force held raid in the house of Kishan @ Hagu Paramanik.

During search with the help of accompany with force, we found that the said person is selling ID liquor in his own house. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit. Accordingly, I seized the said ID liquor (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Kishan @ Hagu Paramanik (30 yrs) S/O- Lt. Tiblu Paramanik of Vill- Rangadih, Hemalpara, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
