Respected Sir,

In producing here with one arrested accused person namely Sampurna Mahato (54 yrs) S/O- Lt. Ghaltu Mahato of Vill- Machatar, P.S.- Balarampur, Dist. Purulia along with seized 16 (sixteen) bottles (DIL KHUSH) Labelled Country Sprit each bottles contains 600 ML in sealed condition (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 17:15 hrs. I received a credible source information that one Sampurna Mahato (54 yrs) S/O- Lt. Ghaltu Mahato of Vill- Machatar, P.S.- Balarampur, Dist. Purulia is selling (DIL KHUSH) without any valid license from in the Grocery Shop of Sampurna Mahato S/O- Lt. Ghaltu Mahato at Mirmi under Balarampur P.S., Dist.-Purulia. Accordingly, I inform to O/C Balarampur P.S. regarding this matter and as per order of O/C Balarampur P.S. I along with force left for Mirmi village to work out the source information. Thereafter we reached at Grocery Shop of Sampurna Mahato at Mirmi village at about 18:05 hrs as per source information, I along with force held raid in the house of Sampurna Mahato.

During search with the help of accompany with force, we found that the said person is selling country sprit bottles (DIL KHUSH) in his own Grocery Shop at Mirmi. On demand, he failed to produce any valid documents or valid License in respect of selling and keeping of said country sprit bottles (DIL KHUSH). Accordingly, I seized the said country sprit bottles (DIL KHUSH) (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled one bottle (600 ML) as a sample. I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act 1909 after maintaining all the formalities as per NHRC guide line.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Sampurna Mahato (54 yrs) S/O- Lt. Ghaltu Mahato of Vill- Machatar, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act and arrange for its investigation.
