Most respectfully begs to state:

- 1. That the Complainant and the Witnesses, are the permanent resident of Village & P.O.-Tumba-Jhalda, P.S.:-Arsha, District:- Purulia, having their residential houses therein.
- 2. That the Accused Persons are the permanent resident of Village:- Gerua, P.S.:-Balarampur, District:- Purulia, having their residential houses therein.
- 3. That the Complainant is known to the Accused No.1 & by lapse of time a good relationship was grown up in between the Complainant & the Accused No.1.
- 4. That on 16/06/2020 the Complainant went to Gerua to meet the Accused Person No.1 whenupon the Complainant felt uneasy due to some illness. Thereafter the Accused Person No.1 told the Complainant that he took him to Purulia Deben Mahato Sadar Hospital, for treatment and also arranged for a vehicle.
- 5. That when the Complainant & the Accused Person No.1 were coming in a vehicle to Purulia suddenly the Accused Person No.1 took the vehicle to the

house of other Accused Persons and they along with 4 other persons also boarded the vehicle.

- 6. That when the vehicle reached outside the Gerua village, the Accused Persons all on a sudden forcing the Complainant to marry the daughter of the Accused Person No.1 namely Tamanna Khatun. On refusal of the Complainant to marry as he is a married person, the Accused Persons & the said 4 persons assaulted him with feast & blows and forcefully brought him to Purulia by showing a dagger.
- 7. That the Accused Persons and said 4 other persons threatened the Complainant if he tried to flee away or raised hue & cry, they will not hesitate to use weapons to assault him. Due to such threatening the Complainant out of fear of life shut his mouth.
- 8. That the Accused Persons including 4 others at Purulia took photograph of the Complainant and asked him to put his signature on some blank papers and out of fear of life he put his signature on those papers. Thereafter the said Accused Persons told him that they will use the said blank papers to procure a document of marriage of the Complainant & said Tamanna Khatun.
- 9. That after few hours the Accused Persons brought the Complainant before the doctor and the doctor after seeing the Complainant prescribed some medicines.
- 10. That thereafter said Accused Persons brought the Complainant & said Tamanna Khatun to Tumba Jhalda and forced the Complainant to keep Tamanna therein
- 11. That at that time the Witness No.2 & some others came there and in their presence the Accused Persons informed that the Complainant married Tamanna and he has to keep her.
- 12. That on hearing such information the Witness No.2 & some others asked the Complainant about such matter when upon he told the real facts before them. Thereafter the Witness No.2 & some others tried to call the villagers and on seeing such situation the Accused Persons alongwith said Tamanna fled away hurriedly.
- 13. That since thereafter the Accused Persons several times threatened the Complainant if he does not hear their words he may be killed but the Complainant always refused to marry said Tamanna as he already has a wife & a son.
- 14. That the Complainant thereafter informed the O/C Balarampur P.S. about the matter in writing but the O/C Balarampur P.S. did not take any action in the matter up-till now.
- 15. That the Complainant also informed the matter to the S.P. Purulia on 29/06/2020 but up-till now no action has been taken by the police.
- 16. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Balarampur P.S. for investigation & further be pleased to pass necessary order
