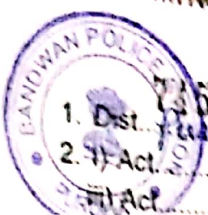

No-JH-05AS/8799, Chassis No-MBLHA11EUC9M04524 & Engine No. HA11EEC9M20610 (3) One Motor Cycle (Scooter) having bearing Reg. No-JH-05CH/4673, Chassis No-ME4JF39HHJ7019472 & Engine No. JF39E74026682 (4) One Hero Super Splendor Motor Cycle having bearing No. JH-05CM/6271, Chassis No. MBLJAW098KGF73510, Engine No. JA05EGK9F13334. I SI Sujit Kr. Majhi of Bandwan PS, beg to report that as per your kind order vide Bandwan PS GDE No-229 Date-07.09.20 & CC No-2652/20 Date-07.09.2020 today i.e on 07/09/2020 at about 13:05 hrs while myself along with force were performing day mobile duty while we reached at Bandwan Chwak bazaar under Bandwan PS and found the above noted persons (Sl. No-1) were coming from Chilla side without any face cover mask and another 07 persons (Sl No-2-8) coming from deferent side with four Motor Cycle without any face cover mask. Accordingly we detained them at Bandwan chawk Bazar under Bandwan PS. On being asked they could not able to give any satisfactory answer for their movement on road and public place at that time, where unnecessary public movement restriction is going on due to lockdown. On enquire it also revealed that without any valid reason they all are moving at Bandwan Chwak Bazar. Lockdown is going on throughout the District of Purulia W.B in view of Pandemic of COVID-19 outbreak. In this respect order of Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020, 10/04/2020 & 01/05/2020. And order of Govt. of West Bengal vide Order No-177-CS/2020 dt-18.05.2020 & 218-CS/2020 dt-30.05.2020, 272-CS/2020 dated 30.06.2020 are in force. As such the above noted persons violated the order during this pandemic situation. Moreover the detained persons were refused to comply the directions which are given by the Central Govt. & State Govt. to combat the severity of COVID-19 pandemic. Accordingly, the above noted persons were arrested after maintaining all formalities regarding arrest and prepared arrest memos and seized the above noted four Motor Cycles from the possession of four M/C rider & brought them to P.S with seized Motor Cycle.

Hence it is prayed before you that above mentioned persons may kindly be prosecuted U/S 188/34 IPC & Read with section 51 of Disaster Management Act, 2005.
