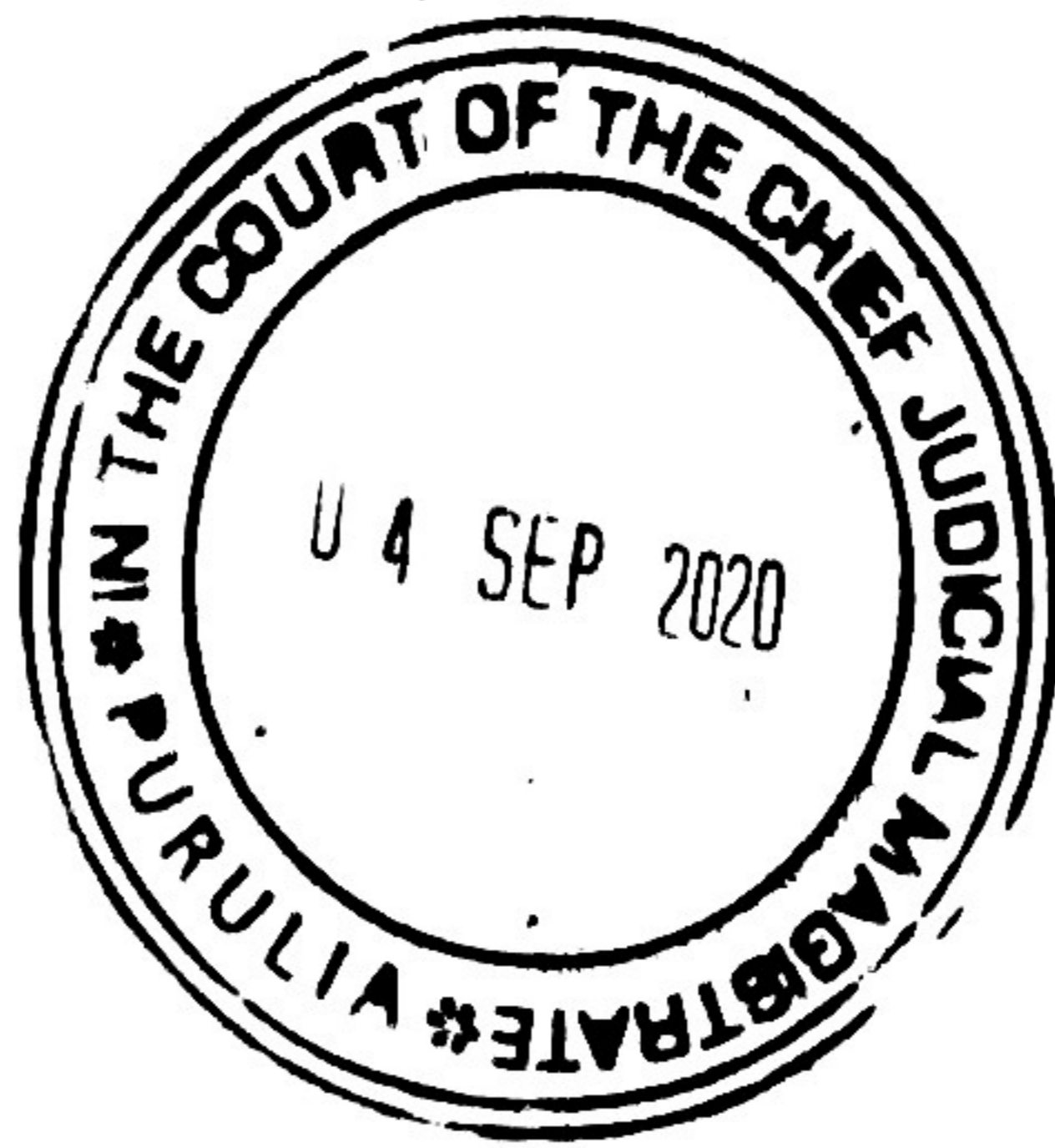

1. That the complainant is a resident of Village- Raotora,
within P.S. Barabazar, Dist. Purulia and within the jurisdiction
of your Honour's Court.

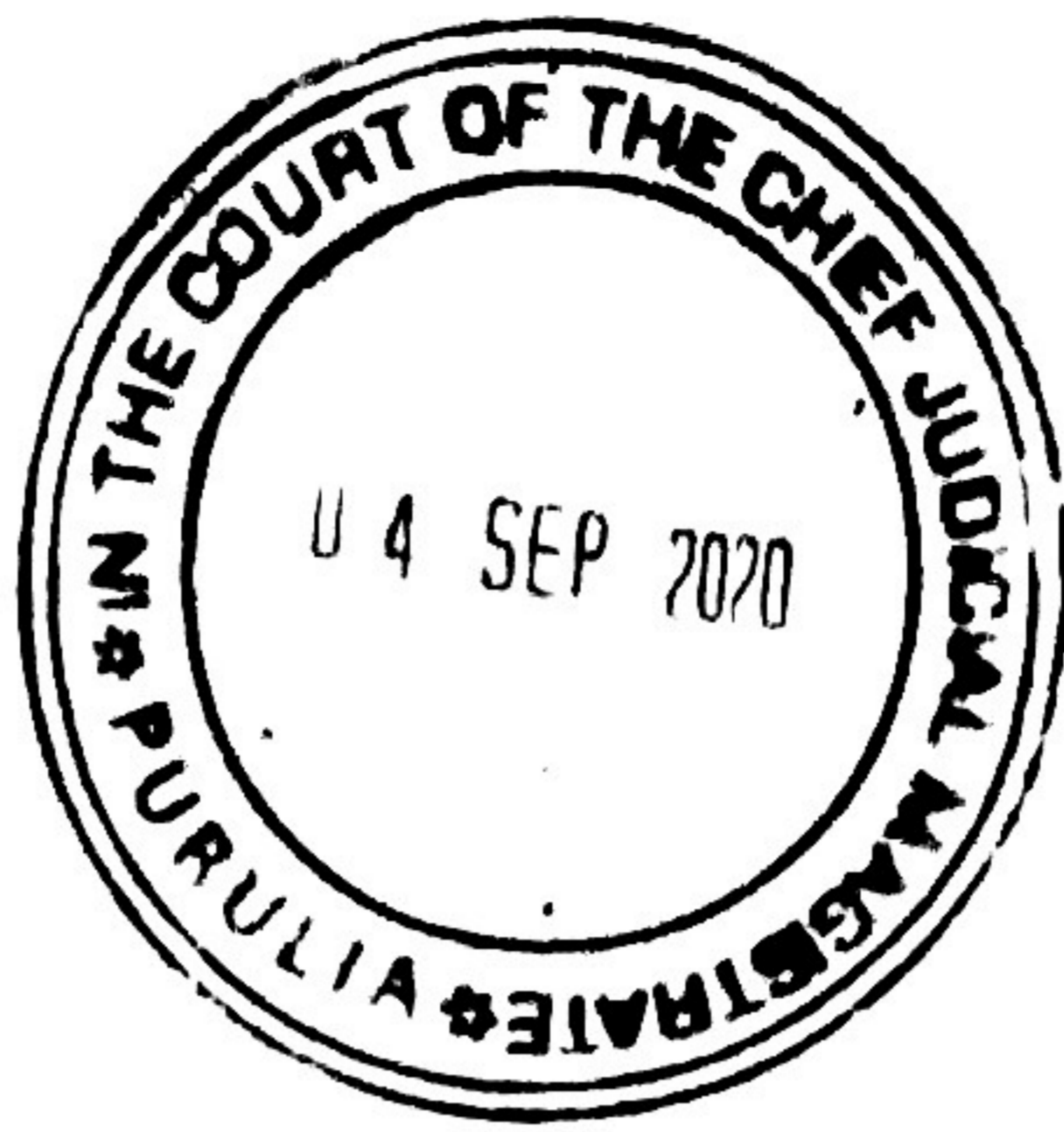

2. That the complainant and the witnesses are the owner in possession of R.S.Plot No.1659 measuring an area 20 acres of Mouza-Raotora. They have perfect right, title, interest and possession over the said plot of land of Mouza- Raotora.
3. That in respect of the aforementioned R.S.Plot No.1659 measuring an area 20 acres of Mouza- Raotora, the above-named complainant and the witnesses have been brought a title suit being T.S.No. 155 of 2008 before the Court of the Ld. Civil Judge (Sr.Div.), Purulia and the said title suit has been decreed in favour of the complainant & the witnesses and against the Govt. of West Bengal and others and the Complainant and the ~~wit~~ said witnesses have also got decree in T.A.No.34 of 2011 against the Govt. of West Bengal and others.
4. That the complainant and the aforesaid witnesses are in ownership and possession of the aforementioned R.S.Plot No. 1659 of Mouza- Raotora since long. They used to possess the said plot of land by growing Rabi crops, vegetables etc. and for looking after their vegetables and Rabi Crops they have constructed a house therein covered by straw wherein they used to reside and to look after their vegetables and Rabi crops.
5. That like previous year this year also the complainant and the said witnesses grew vegetables, Rabi crops etc. in the said plot of land.
6. That on the date of incident i.e. on 15-06-2020 at about 11-30 A.M. while the complainant and the witnesses were doing cultivation work in the said plot of land, the above-named accuseds in furtherance of common intention of all of them most illegally and forcibly entered into the said plot of land and uprooted and damaged the standing crops and vegetables of the complainant and the said witnesses amounting to Rs.1,50,000/-.

and tried to take forcible possession of the said plot of land by dispossessing the complainant therefrom.

Moroso, it is submitted that the accused No.1 Dharanidhar Mahato in connivance with the other accuseds in furtherance of common intention of all of them set fire in the house of the complainant which has been situated in R.S. Plot No.1659 of Mouza- Raatora.

7. That the above-named accuseds ~~have~~ with their common intention have formed an unlawful assembly with deadly weapons in their hands like lathi, tangi etc. and attacked the complainant and others and they have done mischief against the complainant .

8. That while the complainant and the said witnesses tried to raise alarm and also tried to save their house of the said plot of land, the above-named accuseds threatened them to assault physically by dangerous weapons like lathi, tangi etc. and they have also threatened to kill them. So there is every chance of loss of lives at the instance of the aforesaid accuseds.

9. That the complainant informed the matter to the I.C. Barabazar. But the I.C. Barabazar P.S. did not take any step against the aforesaid accuseds.

10. That having no other alternative the ~~the~~ complainant lodged a written complaint to the S.P. Purulia on 19-06-2020 for taking necessary step against the aforesaid accuseds. But uptill now no action has yet been taken by the S.P. Purulia against the aforesaid accuseds.

Hence it is prayed that your Honour may kindly be pleased to admit this criminal Misc. Petition and send it to the I.C. Barabazar P.S. for starting a specific case against the aforesaid

accuseds after treating this petition as an F.I.R. U/S, 156(3) of Cr.P.C.
