Sir,

With due respect I beg to submit before you that on 07/09/2020 at about 10.05 while I, SI Mansa Dutta along with force were engaged on area round duty in Boro area and found the following persons were moving at Boro Kalitala More under Boro PS without wearing Mask, as such I detained them on that spot and immediately took their picture in my personal mobile phone as a token of prove, after narrating them the ground of taking picture. On being asked the following persons could not able to give any satisfactory answer for that not wearing Mask in this pandemic situation. As such the following persons violated the order during the pandemic situation duly promulgated by Govt. of WB in c/w Corona virus/Covid-19. Moreover, all the detained persons were making and circulating false alarm or warning as to disaster or its severity or magnitude, leading to panic among people and as well as the society. Accordingly the following persons were arrested after maintaining all the formalities regarding their arrest and brought them to PS.

1. Subodh Ch. Sardar (24) S/o Bhanu Sing Sardar of Vill- Ranga, PS – Hirbandh, Dist.- Bankura.
2. Monoj Kalindi (28) S/o Subhas Ch. Kalindi, of Vill- Palarpur PS- Nirsha Dist- Dhanbad, Jharkhand.
3. Swapan Majumdar (38) S/o Madhusudan Majumdar of Vill- Rupnagar, Sonari, PO- Sonari, PS- Sonari, Jamshedpur, East Singbhum, Jharkhand- 831011.
4. Ratan Ch. Murmu (37) S/o Lt. Siteswar Murmu, of Vill- Khayerbani, Mamro, PS – Boro, Dist.- Purulia.

Hence it is prayed before you that a specific case may kindly be lodged against the above mentioned persons under proper section of law.
