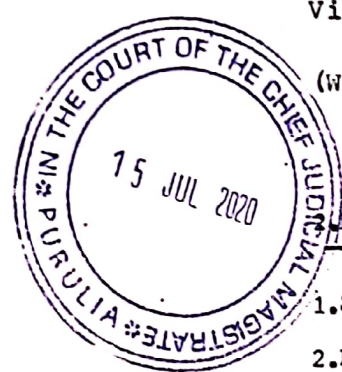

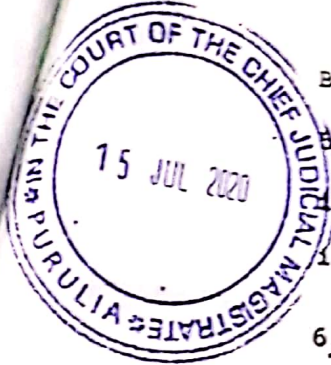

- 2..That the accysed persons are all residents of village Barakadam within P.S. Boro, and within the jurisdiction of this Ld. Court.
- 3..That the accused persons are very notorious persons of the locality and they are creating problems in the said area.
- 4..That on 02/03/2020 in the early morning ~~the~~ ~~at~~ about 5 A.M. the accused namely Sara Tudu S/o Khitu Tudu of an unlawfully criminally tresspass into my vegetable khet and has committed theft of some Bagum from my said khet. The complainant was informed and caught hold with the help of local people the said thief name is Sara Tudu inside my khet.

5...That again on 04/03/2020 with the conspiracy of Sara Tu du ,his sons namely Subo ch Tu du and Akash Tu du and his wife Birmoni Tu du armed with lathi and weapons criminally trespass into the residential house of the petitioner all the accused persons ~~situated~~ started assaulting the petitioner with lathi, and fists and blows when Srimati Tu du wife of the petitioner with lathi and fists blows when Srimoti Tu du wife of the petitioner came to rescue her wife from the cluth of the accused persons , she was also assaulted by fists and blows and lathi and torn her cloths and put hands in the private parts of Srimati Tu du and she was sexually assaulted and harrassed.

when minor Rashimoni daughter of the petitioner came there she was also sexually assaulted by the accused persons.

6...That some local people came to spot when we cried for help and they accused ~~him~~ Birmoni took out Rs. 50,000/- from my pocket which was kept in the pocket after selling the male bafflows of the petitioner.

6...That the matter was reported to O/C Boro P.S. and subsequently to Superintendent of police, Purulia but no action has been takes till date against the accused persons.

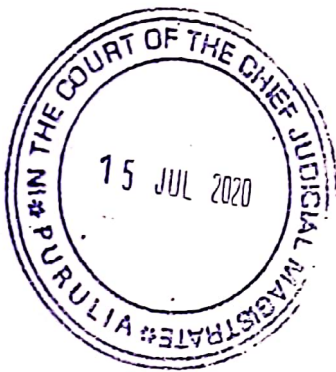
7..That your petitioner is not able to carried the case in his own expenses as such police case is necessary for the same
