In producing herewith the arrested accd. persons namely 1. Bablu Mal (40 yrs.) S/O- Lt. Bhuruk Mal of Vill- Pabra pahari, PS- Kashipur, Dist- Purulia 2. Prasanta Roy (34 yrs.) S/O- Santosh Roy of Vill- Danmari, PS- Chatna, Dist-Bankura, 3. Pabitra Mahato (35 yrs.) S/O- Lt. Basudeb Mahato, 4) Chittaranjan Mahato (32 yrs) S/O- Lt. Basudeb Mahato, 5) Nuhu Ansary (47 yrs) S/O- Muslim Ansary all of Vill- Arita, PS- Purulia(M), Dist- Purulia

Today (11.09.2020) I SI Joydev Mahato along with 1) C/1244 Nilkamal Bauri, 2) J/C-1374 Sk. Belal Ansary, 3) NVF/908 Lakhindar Sing Mura were performing evening mobile duty vide Hura PS GDE No- 404 Dated-11.09.2020 and CC No 2474/20 dtd. 11.09.2020 and as per direction we were engaged for implementation of Govt. rules regarding Lockdown and disaster management plan. At 17.05 hrs, when myself along with force reached at Ladhurka morh area under Hura P.S. we found 05 (five) persons namely 1. Bablu Mal (40 yrs.) S/O- Lt. Bhuruk Mal of Vill-Pabra pahari, PS- Kashipur, Dist-Purulia 2. Prasanta Roy (34 yrs.) S/O- Santosh Roy of Vill-Danmari, PS- Chatna, Dist- Bankura, 3. Pabitra Mahato (35 yrs.) S/O- Lt. Basudeb Mahato, 4) Chittaranjan Mahato (32 yrs) S/O- Lt. Basudeb Mahato, 5) Nuhu Ansary (47 yrs) S/O- Muslim Ansary all of Vill- Arita, PS-Purulia(M), Dist-Purulia without having mask were moving aimlessly. We warned them regarding violation of the order duly promulgated by Govt. of India and Govt. of West Bengal in view of COVID -19 Pandemic, but they did not pay any heed and also making chaos with the Police party. So finding no alternatives we arrested all the above noted 05 (five) persons after observing all formalities regarding arrest and there is every reason to believe that above noted 05 (five) persons came out from their home without having mask and moving aimlessly without any valid reason for making fun, though lockdown is going on throughout the District of Purulia in view of Pandemic of COIVD-19 outbreak vide Govt. of India consolidated order No-40-3/2020-DM-1 (A) Date-24/03/2020 and further modified dated-25/03/2020, 27/03/2020, 02/04/2020, 03/04/2020 and 10/04/2020 for complete restriction measure. As such the above persons violated the order during this pandemic situation duly promulgated by Govt. of West Bengal vide Order No- 272-CS/2020 dated 30.06.2020 and 283-CS/2020 dated 21.07.2020. Therefore they disobeyed Govt. order and committed negligent act likely to spread infection of diseases dangerous to life.

Under the above circumstances, I pray that a cognizable case U/S- 188 IPC & Read with section 51(b) of National Disaster Management Act, 2005 may kindly be started against 05 (five) arrested persons namely 1. Bablu Mal (40 yrs.) S/O- Lt. Bhuruk Mal of Vill- Pabra pahari, PS- Kashipur, Dist- Purulia 2. Prasanta Roy (34 yrs.) S/O- Santosh Roy of Vill- Danmari, PS- Chatna, Dist- Bankura, 3. Pabitra Mahato (35 yrs.) S/O- Lt. Basudeb Mahato, 4) Chittaranjan Mahato (32 yrs) S/O- Lt. Basudeb Mahato, 5) Nuhu Ansary (47 yrs) S/O- Muslim Ansary all of Vill-Arita, PS-Purulia(M), Dist-Purulia and arrange for its investigation.
