Sir,

In producing here with 02 (Two) arrested accused persons namely (i) Sk. Salaham (28) S/O Lt. Sk. Asgar Ali of Vill- Kantadih, P.S.- Jhalda, Dist. Purulia and (ii) Sk. Rofick (30) S/O Lt. Sk. Salem of do and brought under seizure 01 (one) Tractor having Reg. No WB55A 7072 attached with a sand loaded trolley. The fact in brief is that today (21.09.2020) during anti crime day mobile duty myself along with i) C/386- Shibendu sinha and ii) C/696- Gora Pada Pal vide Jhalda PS CC No- 2693 Dated- 21/09/2020 and Jhalda PS GDE No- 692 Dated- 21/09/2020 at about 13:15 hrs received a credible source information that one tractor was carrying sand illegally and coming from Tulin Subarnarekha ghat & going towards Jhalda side. Accordingly, myself along with force left to work out the said source information and reached at Mosina more on Purulia Ranchi road under Jhalda PS and started NAKA checking. We saw one Tractor coming from Tulin side at 13:45 hrs. and saw 03 (three) persons sitting on the tractor. We gave signal to the driver of said tractor to stop but seeing the Police party driver and others tried to flee away keeping the tractor on road. We chased and managed to apprehend 02 (two) of them but one fled away. On asked they disclosed his identity as mentioned earlier. On demand, they failed to produce any valid papers in respect of the Tractor and attached Trolley as well as loaded sand though sufficient time was given. During interrogation, they confessed that they in convince with the driver and owner of said seized Tractor are doing this illegal business of sand and they have no Challan/paper for carrying loaded sand. They also confessed that driver of the tractor was with them but fled away. Then, I ASI Sk. Abdul Jamshed arrested (i) Sk. Salaham (28) S/O Lt. Sk. Asgar Ali of Vill- Kantadih, P.S.- Jhalda, Dist. Purulia and (ii) Sk. Rofick (30) S/O Lt. Sk. Salem of do under proper arrest memo and also seized the Tractor having Reg. No- WB55A 7072 with attached sand loaded Trolley (approx 100 cft).

On return to P.S., Put the arrested accused person into the P.S. Lock UP after maintaining all formalities, kept the sand loaded seized vehicle at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Sk. Salaham (28) S/O Lt. Sk. Asgar Ali of Vill- Kantadih, P.S.- Jhalda, Dist. Purulia and (ii) Sk. Rofick (30) S/O Lt. Sk. Salem of do (iii) Driver of the Tractor having Reg. No- WB55A 7072 and (iv) Owner of the Tractor having Reg. No- WB55A 7072 under proper section of law.
