In producing here with 03 (Three) arrested accused persons namely (i) Chutubabu Kumar (34) S/O Lt. Gopal Kumar of vill- Chekya, PS-Kotshila, Dist. Purulia (ii) Bibison Gorait (22) S/O Anirudha Gorait (iii) Kansha Gorait (22) S/O Sakti Gorait both of vill- Chatrani, PS-Kotshila, Dist. Purulia and brought under seizure 04 (Four) Tractors (i) One Tractor having Reg. No WB55/5994 attached with trolley loaded with sand (approx 100 cft), (ii) Tractor having Reg. No WB55B/1701 attached with trolley loaded with sand (approx 100 cft), (iii) Tractor having Reg. No WB55A/5590 attached with trolley loaded with sand (approx 100 cft) and (iv) New Mahindra Tractor without number plate having Engine No and Chassis No-RFNE04501 attached with trolley loaded with sand (approx 100 cft). The fact in brief is that today (05.09.2020) evening at about 19:55 hrs received a credible source information that 04 (Four) tractors were carrying sand illegally and coming from Tulin ghat & going towards Jhaldia side. Accordingly, myself along with force left PS to work out the said source information. This refers to Jhaldia PS GDE No- 157 Dated- 05/09/2020 & Jhaldia PS CC No- 2573/2020 Dated- 05/09/2020. Then, we intercept the said Tractors at Mosina more (Purulia Ranchi road) under Jhaldia PS at about 20:15 hrs and found the above noted tractors were tagged with trolley loaded with sand. Seeing the Police party drivers and others who were on those tractors started to flee away. We tried to apprehend them. We able to detain 03 (Three) persons of one tractor having Reg. No WB55/5994 but others who were attached with rest 03 (three) tractors fled away. We waited for reasonable time but nobody reached there. During interrogation of 03 (Three) detained persons, Chutubabu Kumar (34) S/O Lt. Gopal Kumar of vill- Chekya, PS-Kotshila, Dist. Purulia admitted that he is the owner and driver of Tractor having Reg. No WB55/5994. Other 02 (two) persons (i) Bibison Gorait (22) S/O Anirudha Gorait (ii) Kansha Gorait (22) S/O Sakti Gorait both of vill- Chatrani, PS-Kotshila, Dist. Purulia were also his associates and seated on tractor having Reg. No WB55/5994. On asked they disclosed their identity as mentioned earlier. On demand, they failed to produce any valid papers in respect of the Tractor and attached Trolley as well as loaded sand though sufficient time was given. During further interrogation it is known that the owner of the vehicle Chutubabu Kumar along with other 02 (two) associates as noted earlier is doing this illegal business of sand and they have no Challan/paper for carrying loaded sand. There is every reason to believe that the drivers and owners of 04 (Four) above noted tractors along with others are doing illegal business of sand and none of them has any challan / paper for carrying loaded sand. Then, I ASI Dulal Singh Sardar arrested above noted 03 (Three) aced. persons under proper arrest memo and also seized 04 (Four) Tractors: (i) One Tractor having Reg. No WB55/5994 attached with trolley loaded with sand (approx 100 cft), (ii) Tractor having Reg. No WB55B/1701 attached with trolley loaded with sand (approx 100 cft), (iii) Tractor having Reg. No WB55A/5590 attached with trolley loaded with sand (approx 100 cft) and (iv) New Mahindra Tractor without number plate having Engine No and Chassis No-RFNE04501 attached with trolley loaded with sand (approx 100 cft).

On return to P.S., Put the arrested accused persons into the P.S. Lock Up after maintaining all formalities, kept the sand loaded seized Tractor at PS compound and I do here by submitting written complaint before you to start a cog case against (i) Chutubabu Kumar (34) S/O Lt. Gopal Kumar of vill- Chekya, PS-Kotshila, Dist. Purulia (ii) Bibison Gorait (22) S/O Anirudha Gorait (iii) Kansha Gorait (22) S/O Sakti Gorait both of vill- Chatrani, PS-Kotshila, Dist. Purulia, (iv) Owner of Tractor having Reg. No WB55B/1701, (v) Driver of Tractor having Reg. No WB55B/1701 (vi) Owner of Tractor having Reg. No WB55A/5590 (vii) Driver of Tractor having Reg. No WB55A/5590 (viii) Owner of New Mahindra Tractor without number plate having Engine No and Chassis No-RFNE04501 (ix) Driver of New Mahindra Tractor without number plate having Engine No and Chassis No-RFNE04501 and others under proper section of law.
